# **Car and Cash Terms and Conditions**

# **Effective August 2024**

TERMS AND CONDITIONS APPLICABLE TO THE CAR AND CASH PROMOTION:

- 1. The promotion is authorised under NSW Authority No. TP/03733.
- 2. The Promoter is Mingara Recreation Club Ltd, trading as Lantern Club ABN 81 001 662 648.
- **3.** The Car and Cash promotion is only open to financial current Ordinary, Special, Life and Provisional members of Lantern Club (the Club). However, the promotion is not open to any member whilst their membership is suspended.
- **4.** Members who are un-financial are not eligible to participate or claim a prize in this promotion.
- **5.** Members of other registered clubs that encompasses the Mingara Leisure Group are not eligible to participate or claim a prize in this promotion.
- **6.** Important conditions apply on the Bonus Prize see clauses 35 to 53 for further details. At each Minor Draw one (1) chance at claiming the Bonus Prize is made available but this chance may not be claimed.

#### **Promotional Period**

7. The promotional period commences on and from 10:00 hours Sunday 11 August 2024 and concludes with the last Major Draw on Sunday 29 July 2029.

#### **Promotion Entry Entitlements**

- **8.** A member is entitled to one (1) ticket in the Promotion for each one hundred (100) Reward Points which the member spends with the Club or with any participating outlet on the Club's licensed premises.
- **9.** A member is also entitled to one (1) ticket in the promotion by swiping their membership card at any of the Membership Kiosks located throughout the Club's premises. A member is only entitled to one (1) such ticket each day (00:00 hours to 23:59 hours).
- 10. A member may also be allocated bonus tickets, up to one hundred (100) tickets per occurrence, throughout the promotional period by participating in digital and Club promotions. These include but are not limited to attendance at shows and events, the completion of online competitions and surveys and random swipe bonuses issued through the Lantern Club Membership Kiosks.
- **11.** Multiple tickets are permissible.
- 12. For a member to be entitled to a ticket (s) into the Promotion in the circumstances outlined, they must initiate the redemption of tickets into entries to be eligible into the Promotion's minor, second chance and monthly draws. A member can only initiate the printing of tickets at one of the Membership Kiosks within the Club's premises. On each occasion, the tickets issued will reflect entry/entries to which the member has become entitled since last initiating redemption into the draw. The tickets will show the member's number of entries that have been recorded and acknowledged. However, the binding evidence of an entry is the database record in the Club's relevant computer system, and not any printed tickets.
- **13.** Rights of entry into the Promotion can only be acquired and exercised during the promotion period as stated under the Promotion Period.

#### Minor Draw Details and Procedures

- **14.** For any Wednesday Minor Draw, rights of entry cease to accrue from 19:15 hours on the day of the Draw. Members must initiate tickets for any right of entry no later than 19:15 on the day of the Draw.
- **15.** For any Sunday Minor Draw, rights of entry cease to accrue from 17:00 hours on the day of the Draw. Members must initiate tickets for any right of entry no later than 17:00 on the day of the Draw.
- 16. For each Wednesday Minor Draw, on the day of the Draw commencing at approximately 19:45 hours, (five) 5 ticket numbers and corresponding member names will be drawn one by one and from the Club's eBet and/or BSG computer systems. As each member's name is drawn it will be announced via the Club's PA system. For each Sunday Minor Draw, on the day of the Draw commencing at approximately 17:30 hours, (five) 5 ticket numbers and corresponding member names will be drawn one by one from the Club's eBet and/or BSG computer systems. As each member's name is drawn it will be announced via the Club's PA system.
- **17.** The member must be on the Club's licensed premises<sup>i</sup> at the time of the first announcement of the member name and membership number to be eligible to claim the prize.
- 18. The announced member must present themselves at the designated promotional stand within the Club's premises within 4 minutes of their name being called to claim a prize in the Minor Draw, otherwise the announced member is not entitled to a prize. In that case a redraw will take place. This process will be repeated until the announced holder of the five (5) drawn tickets have duly presented themselves and been acknowledged. The Club in its discretion may adjourn the process to continue at the next Minor Draw date, if all prizes are not duly claimed by 22:00 for a Wednesday Minor Draw or by 20:30 for a Sunday Minor Draw. In the event prizes are not claimed at the final Minor Draw of the calendar year then the draw will continue until all prizes are claimed. Although five (5) numbers will be drawn, a single member may be the holder of multiple drawn entries.
- **19.** For each Minor Draw the Club will choose a promotional theme that allows the holders of the five (5) Minor Draw winning tickets to randomly select one (1) prize from eight (8) available prizes. The prizes available at each Minor Draw are;

1 x \$125 Cash, 1 x \$150 Cash, 1 x \$175 Cash, 1 x \$200 Cash, 1 x \$225 Cash, 1 x \$250 Cash, 1 x \$300 Cash and 1 x CHANCE to win the bonus prize

- 20. At the end of each Minor Draw, the three (3) unclaimed prizes will be revealed.
- 21. At each Minor Draw, two winners will also be selected at random to attend the next monthly Major Draw as a finalist. Selected Minor Draw winners need to carefully check the other requirements under these conditions if they wish to have a chance of claiming the Major Draw prize.

# **Second Chance Draws**

- **22.** The Second Chance draws will take place on the last Sunday of each month.
- **23.** All entries redeemed after the close of the previous Monthly Major Draw, through to the current Monthly Major Draw are eligible to participate in the Second Chance Draw.
- **24.** On the day of the Second Chance draw commencing at approximately 18:30, five (5) entry numbers and corresponding member names will be drawn from the Club's eBet and/or BSG computer systems. As each member's name is drawn it will be announced via the Club's PA system.

25. The announced member must present themselves at the designated promotions stand within the Club's premises within four (4) minutes of their name being called to claim a prize of \$100 and a place in the Monthly Major draw, otherwise the announced member is not entitled to a prize. In that case a redraw will take place. This process will be repeated until five (5) second chance winners have duly presented themselves and been acknowledged. The Club in its discretion may adjourn the process to continue another time and day, if all prizes are not duly claimed by 20:30 on the day of the draw. A single member may be the holder of multiple drawn entries.

# **Monthly Major Draw**

- **26.** The Monthly Major Draws will take place on the last Sunday of each month.
- 27. The Monthly Major Draw will occur after the Second Chance draw at approximately 19:30.
- **28.** The only entrants in a particular Monthly Major Draw are the finalists resulting from each of the weekly Minor Draws held since the last Monthly Major Draw, together with the Second Chance Draw winners. A single member may be the holder of multiple drawn entries.
- **29.** All Monthly Major Draw finalists must register at the designated promotions stand between 17:00 and 18:00 on the day of the draw in order to confirm their attendance for the Monthly Major Draw and to claim their \$50 prize.
- **30.** Eligible finalists who fail to register between 17:00 and 18:00 will be disqualified. In this case a redraw will occur using the same format as the second chance draws and will be repeated for each unclaimed finalist.
- **31.** At approximately 19:30 on the day of the Monthly Major Draw, the name of each of the eligible finalists for that Draw will be announced via the Club's PA system. A finalist must then present themselves at the designated promotions stand within the Club's premises within 4 minutes of their name being called, in order to be eligible for the Prize. A finalist, who does not present themselves within that time and then stay to participate in the determination of the Monthly Major Prize winner, is disqualified from participating and is no longer eligible to win the Monthly Prize. In fairness to all who participate in the promotion, this rule will not be varied just because it may be impossible or personally inconvenient for a particular finalist to be present.
- **32.** The Club in its discretion may adjourn the Monthly Major Draw announcements or prize process to another time and day, if in the reasonable opinion of the Club that is necessary because of any delay in completing the earlier Second Chance Draw.
- **33.** From the finalists who are then present, the ultimate winner of the particular Monthly Major Prize will be determined. The particular way in which the game of chance is to be conducted will be explained to the finalists collectively and over the Club's PA system to the audience. The game of chance will then proceed and the first winner will be declared the winner of the Monthly Prize.
- **34.** The Monthly Major Prize in this promotion is \$5,000 cash.

### **Bonus Prize Chance Draw**

**35.** At each Weekly Draw one (1) of the eight (8) prizes available is a chance at the Bonus Prize. The Bonus Prize, is not a guaranteed prize as part of this promotion. The Bonus Prize will be on display and full details of the Bonus Prize will be available at Lantern Club's Reception Desk and on Lantern Club's Website. The Bonus Prize is a Car, valued between \$20,000 and \$35,000 and is described at the time of the draw. The prize includes; on road costs (CTP Insurance, Private Registration, Stamp Duty and GST). The winner is responsible for

- arranging their own comprehensive insurance. The prize is not transferable or redeemable for cash.
- **36.** Subsequent bonus prizes are subject to vehicle availability and model changes.
- **37.** If the announced member selects the one (1) prize stating SPIN FOR THE CAR from eight (8) prizes available, the member will have the chance to Spin the Promotional Wheel for a 1 in 50 chance to win the prize as displayed as outlined in clause 35.
- 38. There are fifty (50) wedges on the wheel, containing the following prizes;

  1 x Bonus Prize, 1 x \$300 Cash, 2 x \$250 Cash, 2 x \$225 Cash, 2 x \$200 Cash, 2 x \$175

  Cash, 3 x \$150 Cash, 3 x \$125 Cash and 34 x \$100 Cash
- **39.** For the spin to be valid it must complete two (2) x 360 degree revolutions and land completely on a prize, if a spin does not make two (2) complete revolutions of the wheel or lands in between two (2) prizes on a spoke the spin will be void and needs to be re spun.
- **40.** If the spin lands on the Bonus Prize wedge, the member will be able to choose from taking the car or \$20,000 cash instead. See clause 53.
- **41.** The Club in its discretion may adjourn the process to continue at another advertised day and time, if a prize is not duly claimed by 22:00 hours.

#### **Guaranteed Tesla Draw**

- **42.** A Guaranteed Tesla Draw will take place on Wednesday 28 August 2024. Between Wednesday 3 July to Wednesday 28 August, the 'SPIN TO WIN THE TESLA' coin will be replaced with a 'TESLA KEY' coin. Members who successfully choose the 'TESLA KEY' coin will receive \$100 and a key straight into the guaranteed Tesla draw on Wednesday 28 August where there will be a 1 in 15 chance to win the Tesla on display.
- **43.** After the regular Minor Draw on Wednesday 28 August, a Second Chance Draw will take place at 8:30pm where further Tesla keys will be awarded to make up the 15 finalists/keys that are required to run the guaranteed Tesla draw. The Second Chance Draw will be randomly drawn using the list of ticket redemptions from 5pm Sunday 30 June (Major Draw) to 7:15pm Wednesday 28 August. All Second Chance winners will also receive \$100.
- **44.** The maximum number of keys in the guaranteed Tesla draw is 15.
- **45.** A single member may be the holder of multiple keys.
- **46.** At 9pm, we will run the guaranteed Tesla draw. There will be 15 keys to choose from. 1 key will unlock the promo safe. This member will win the Tesla on display.
- 47. During this period, the cash prizes on display will be:

1 x \$400

1 x \$300

1 x \$250

1 x \$200

1 x \$175

1 x \$150

1 x \$125

#### Clearing of tickets from member accounts

- **48.** All accrued Car and Cash tickets on member accounts will be cleared at 17:00 on the night of the Monthly Major Draw.
- **49.** Prior to 17:00 on the Monthly Major Draw, members must redeem these tickets or they will be ineligible for use as they will be cleared.

**50.** Post 17:00 on the Monthly Major Draw, members who spend their Reward Points, triggering Car and Cash tickets to their account, will be able to redeem their tickets up until 17:00 at the next Monthly Major Draw.

## Proof of qualification and payment of prizes

- **51.** A member claiming a prize must identify themselves and prove their identity and eligibility to the reasonable satisfaction of the Club, in order to participate or for a prize to be awarded to them.
- **52.** There will be no cash prize issued after 22:00 hours. Where the prize is won after 22:00 hours, the member will be issued the full amount of the prize by Electronic Funds Transfer; no part-cash will be given.
- **53.** Prizes up to \$2,000 will be paid in cash within 1 hour of the prize being awarded. Any balance will be paid by Electronic Funds Transfer within 3 business days after the draw. The full prize amount can be paid in this manner, if desired.

#### **GENERAL TERMS AND CONDITIONS APPLICABLE TO ALL CLUB PROMOTIONS**

- **54.** The following persons are not eligible to participate in the promotion or win:
  - a. [Club officers; executives and families; other employees] Club directors or auditors; Club executives (and the immediate family of any executive); other Club employees;
  - Econtractors directly involved in the promotion, and families] Officers and employees of suppliers or contractors to the Club, who are directly involved in any aspect of the promotion (and the immediate family of any of them);
  - c. [People who work on the Club's premises] Persons whose usual place of work is within premises owned or leased by the Club, who are employed by any of the licensees or lessees of the Club:
  - d. [People working at the Club at the time] Persons employed by any other supplier or contractor of the Club who at or about the time of a particular draw, are on the Club's premises in that capacity as such an employee.
- **55.** Information on how to enter forms part of the promotion conditions.
- **56.** The Club's promotional areas (for announcements of all draws) are as determined by the Club in its discretion. Certain areas within the main club building are excluded including function rooms if in use for a private event at the time of the draws. The Club's car parks, bowling greens, outer building detached from the main club building and entry airlock do not form part of the Club's premises for the purposes of Club promotions.
- **57.** The Club may require a winner to sign a legal acknowledgment, release and receipt in conformity with these conditions and in a form reasonably required by the Club, in order to be paid a prize.
- 58. The Club in its reasonable discretion may (but is not obliged to) cancel, suspend, terminate, modify or adjourn the promotion or any or all draws or any or all processes for the selection of any winner, where circumstances unexpected by the Club arise in relation to the promotion or a draw. Unexpected circumstances could include (but are not limited to) technical difficulties, power outages, infection by computer virus, computer bug, tampering, unauthorised intervention, fraud, technical failures or errors, and any other unexpected circumstance beyond the reasonable control of the Club which corrupts or affects the administration, security, fairness, integrity or proper conduct as planned of the promotion. The Club's rights are subject to any direction given under any relevant legislation or in connection with any permit under which the promotion is conducted.

- 59. The Club's decisions in relation to the promotion may be made by the Club's CEO or his delegate or delegates from time to time (who may but need not be a Club executive), including decisions in relation to the appointment of a judge or judges in relation to the promotion or a particular draw or draws. The Club's CEO also may (but is not obliged to) appoint one or more scrutineers for a particular draw or draws or all draws or a prize process or all prize processes. Decisions by the Club's CEO, and subject to any countermanding decision by the Club's CEO also decisions by any such delegate or judge, are final. No such decision requires any consultation. No correspondence will be entered into in relation to any such decision.
- **60.** Members wishing to be sure of entry should seek to complete transactions and to initiate ticket printing early, to reduce the risk of being excluded because of any shortage of service points or because of delay or crowding.
- **61.** The Club is not responsible for, and is not obliged to delay a draw or a process of selecting a winner because of any delay or impediment in connection with the admission of members or in the completion of entries to the promotion or in seeking to attend any draw or to attend the process of selecting a winner.
- **62.** The Club is not responsible for members being located in areas within the Club's premises in which PA announcements are not able to be heard, nor for the audible integrity of those announcements.
- **63.** A prize will not be awarded or paid where in the Club's reasonable opinion it arises as a result of a machine or other technical malfunction.
- **64.** The Club has no liability for acting on or promulgating any incorrect or inaccurate information, due to any error to any equipment or programming associated with or utilised in the promotion or any technical error or error by any third party.
- **65.** Where the Club's decision is that a person claiming a prize is not eligible to participate or has not qualified to win the prize or, on the basis of these conditions, is not entitled to the award of a prize, then in the case of a weekly draw, the Club is entitled not to award the prize and the prize may remain at the same amount for another scheduled draw on that night, or it may jackpot as specified elsewhere in these conditions.
- **66.** Prizes are strictly not transferable or negotiable.
- 67. The collection, use and disclosure of personal information provided to the Club in the course of the promotion is subject to these conditions and is otherwise governed by the Club's Privacy Policy. Please ask for a copy of that Policy if you are not aware of its contents. Members not wishing to participate in automatic draws should notify the Club's CEO's office in writing as soon as possible.
- **68.** If the Club in good faith awards or pays a prize to someone appearing to the Club to be the prize winner, then to the maximum extent permitted by law that award or payment fully discharges the Club from all liability to the actual prize winner in relation to that prize.
- **69.** Tax and financial implications may arise from winning a prize and winners should seek independent tax and financial advice before accepting. The Club is not responsible for any such advice.
- **70.** No member is required to participate. Participation in the promotion is solely at the option of individual members. Members should not participate unless they are satisfied that they completely understand the way in which the promotion operates and these conditions. Members not wishing to participate in automatic draws should notify the Club's CEO's office in writing as soon as possible.
- **71.** These conditions cannot be varied for an individual member.
- **72.** The Club determines the designated clock from which draws are timed.

- **73.** A person by claiming or accepting a prize agrees that the Club may use their name, suburb, photograph, image and likeness for the purpose of promoting the Club and agrees to cooperate with the Club to allow their photo to be taken for those purposes.
- **74.** Neither the Club nor any of its officers, employees, contractors or agents, has any liability for any loss or damage of any nature or for injury or death, sustained in connection with the promotion or any prize, except any minimum liability which cannot be excluded by law (if any).
- **75.** Members will be notified of this promotion through advertising in the Club's premises, PA announcements, social media, electronic communications or by other means at the Club's discretion. All advertising material will contain the approved Permit Number.

<sup>&</sup>lt;sup>1</sup> The Club's licensed premises are as determined by the Club in its discretion and comprise the licensed club building and designated outdoor areas (namely outdoor gaming areas, restaurant alfresco areas and smoking areas). The Club's front door entry airlock, car parks and bowling greens are not considered to form part of the Club's licensed premises for the purposes of Club promotions.
