## TERMS AND CONDITIONS APPLICABLE TO THE LION NATHAN BEVERAGE PROMOTION:

- 1. Instructions on how to enter and other details contained within promotional advertisements for this competition form part of the conditions of entry.
- **2.** By entering this promotion, entrants agree to abide by these terms and conditions.
- 3. The promotion is open to all members and guests of Lantern Club.
- 4. The promotion period is from 10am Sunday 1 September to 7:30pm Friday 11 October 2024.
- **5.** To enter this promotion, an entrant must:
  - Be 18 years of age or over
  - Purchase any Lion Nathan tap schooner sized product to receive 1 entry ticket per product
  - Place their entry ticket in the promotion barrel located at the main bar
- 6. Purchases of any packaged Lion Nathan product do not receive entry tickets into the promotion.
- 7. Purchases of Hahn 3.5 products will generate 1 bonus entry ticket per product.
- **8.** For members, each entry ticket will be pre-filled with their full name and membership number. For guests, each entry ticket will require the guest to write their full name, contact number and email address.
- 9. Multiple entries by the same entrant are permissible.
- 10. There are 2 major prize packages and 5 minor prizes to be won. The major prize package includes a 2 person return flight to Gold Coast airport from Sydney airport, 3 nights of accommodation at QT Gold Coast from Tuesday 12 November to Thursday 14 November 2024, airport transfer from Gold Coast airport to QT Gold Coast on Tuesday 12 November, airport transfer from QT Gold Coast to Gold Coast airport on Friday 15 November, 2 premium tickets to the Pearl Jam concert on Wednesday 13 November and \$500 spending money in the form of a Visa gift card.

- **14.** All entry tickets will be cleared from the promotion barrel after each minor prize draw.
